I, the undersigned, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, agree as follows (the "Agreement"):

- License. I hereby grant to WM Symposia, Inc. ("WMS") the following rights:
 - an exclusive, worldwide, perpetual, and royalty-free license (i) to make audio, video, and other recordings ("Recordings") of my presentation in the above Symposium (the "Presentation"); and (b) to use, reproduce, publish, publicly perform, broadcast, publicly display, modify the formatting of, excerpt, abridge from, distribute, and sell the Recordings, in whole or in part, individually or in a collective work or compilation, and in any and all forms and media, whether now known or later developed;

- Paper/Presentation Works. I agree to submit any Works I plan to use in my Presentation to WMS by no later than January 12, 2024. I agree that WMS may, in its sole discretion, request changes to the Works to comply with WMS policies. I hereby release and discharge WMS, its affiliates and licensees, and all their officers, directors, employees, shareholders, legal representatives, agents, successors and assigns, from any and all claims, demands, and causes of action that I may have against it for use of my Presentation, the Recordings, or the Works, including, but not limited to, any claims based on the right of privacy, the right of publicity, copyright, libel, or slander.
- Representations and Warranties. I represent and warrant that:
 - (a) my Presentation and Works do not and will not infringe, violate, or otherwise conflict with the rights of any third party.
 - I have the full right, capacity, and authority, including all intellectual property, publicity, and other rights, needed to execute this Agreement and to grant the rights herein;
 - if I check the box below, I created any Works I plan to use in the Presentation within the scope of my duties as an employee or independent contractor for the U.S. federal government, such that the Works are not entitled to copyright protection.

I agree to indemnify and hold harmless WMS, its affiliates and licensees, and all their officers, directors, employees, shareholders, legal representatives, agents, successors and assigns, from and against any damages, liabilities, costs and expenses (including reasonable attorneys' and professionals' fees and court costs) to the extent they relate to my breach of any representation or warranty under this Agreement.

Miscellaneous. I acknowledge and agree that: (a) this Agreement contains the entire understanding and agreement between me and WMS with respect to my Presentation and the Works; (b) all of the rights I am granting to WMS herein are irrevocable and extend to WMS and its successors, assigns, and licensees; (c) this Agreement binds me and my heirs, executors, successors, and assigns; (d) this Agreement shall be governed by
